Interest Rates and Interest Charges

Penalty APR and When it Applies	18.0% This APR may be applied to your account if we: <ul style="list-style-type: none"> Have not received a required Minimum Payment within sixty (60) days after the payment is due. How Long Will the Penalty APR Apply?: This increased APR will remain in effect for no longer than six (6) months, provided that you make all required Minimum Payments on time during that period. If you fail to make all required Minimum Payments on time for six (6) consecutive billing cycles, the 18% APR will remain in effect until you do so.
Paying Interest	Your due date is at least 25 days after the close of each billing cycle. We will not charge you any interest on purchases if you pay your entire balance by the due date each month. We will begin charging interest on cash advances, balance transfers, convenience check, and overdraft protection transactions on the transaction date.
